Consequently, these shares have not yet been updated by the RTA as on 30th June, 2025, and therefore, the said 5,66,50,000 shares have not been reflected in the RTA report. As a result, the number of shares reflected in the RTA report is lesser by 5,66,50,000 as compared to the records available on the MCA portal.
